No action shall be taken involving any personal risk without suitable training. Fire residues and contaminated fire extinguishing water must be disposed of in accordance with local regulations. In the event of fire and/or explosion do not breathe fumes.

### **Section 6. Accidental Release Measures**

#### **Personal Precautions, Protective Equipment and Emergency Procedures**

Remove all sources of ignition. Ensure adequate ventilation. Keep people away from and upwind of spill/leak. Avoid inhalation, ingestion and contact with skin and eyes. When workers are facing concentrations above the exposure limit they must use appropriate certified respirators. Ensure clean-up is conducted by trained personnel only. Refer to protective measures listed in sections 7 and 8.

#### **Methods and Materials for Containment and Cleaning Up**

**Small spill** Eliminate all ignition sources if safe to do so. Stop leak if without risk. Move containers from spill area. Dilute with water and mop up if water-soluble. Alternatively, or if water-insoluble, absorb with an inert dry material and place in an appropriate waste disposal container. Dispose of via a licensed waste disposal contractor.

**Large spill** Eliminate all ignition sources if safe to do so. Stop leak if without risk. Move containers from spill area. Prevent entry into sewers, water courses, basements or confined areas. Wash spillages into an effluent treatment plant or proceed as follows. Contain and collect spillage with non-combustible, absorbent material e.g. sand, earth, vermiculite or diatomaceous earth and place in container for disposal according to local regulations. Dispose of via a licensed waste disposal contractor. Contaminated absorbent material may pose the same hazard as the spilled product. See Section 13 for additional disposal information.

#### **Environmental Precautions**

Do not allow contact with soil, surface or ground water.

### **Section 7. Handling and Storage**

#### **Precautions for Safe Handling**

**Protective Measures:** Put on appropriate personal protective equipment (see Section 8).

**Advice on Safe Handling:** Keep away from fire, sparks and heated surfaces. Take necessary action to avoid static electricity discharge (which might cause ignition of organic vapours). Open container carefully as content may be under pressure. Wash hands thoroughly after handling. Eating, drinking and smoking should be prohibited in areas where this material is handled, stored and processed. Workers should wash hands and face before eating, drinking and smoking. Remove contaminated clothing and protective equipment before entering eating areas. See Section 8 for additional information on hygiene measures.

**Conditions for Safe Storage:** Keep away from heat and sources of ignition. Keep out of reach of children. Keep container tightly closed. Store in suitably labelled original container protected from direct sunlight in a dry, cool and well-ventilated area, away from incompatible materials (see Section 10) and food and drink.
